Locals Endorse Primary Candidate for Cuyahoga Executive

Representatives of OEA's Cuyahoga County locals met on Monday, December 2, and voted to endorse **State Representative Armond D. Budish (D-12)** in the Democratic primary for Cuyahoga County Executive.

The position of Cuyahoga County Executive affects about 29% of NEOEA's active and retired members.

The position of Cuyahoga County Executive is sometimes said to be the second-most powerful elected position in Ohio, and due to the county's Democratic majority, the Democratic nominee is commonly regarded as a strong favorite to win the position.

Of Ohio's 88 counties, only Summit and Cuyahoga have a county executive form of government. Cuyahoga County voters began electing a County Executive in 2010 by approving a new county charter. Cuyahoga County locals made no endorsement in that year's Executive race, so this year's action was their first experience with this process.

The steps that led to the endorsement vote began in August, when several declared Democratic primary candidates approached NEOEA leaders to inquire about an endorsement. NEOEA does not endorse candidates, but OEA rules permit locals to make endorsements. At a September meeting, NEOEA's Legislative Committee approved the idea of bringing the Cuyahoga County locals together to decide whether to begin an endorsement process. At its October meeting, NEOEA's Board of Directors approved a process to consider recommendations to the 9,400 active and retired NEOEA members who either live or work in Cuyahoga County at its October meeting.

Presidents and representatives of interested Cuyahoga County OEA locals met on November 21 and decided to begin an endorsement process. The caucus developed a questionnaire to send to the three declared Democratic candidates and scheduled screening interviews.

On December 2, local presidents interviewed Representative Budish and two other declared candidates for the Democratic nomination: former Sheriff Robert Reid and State Senator Shirley A. Smith (D-21).

As News and Views goes to print, no Republican candidate has approached OEA's Cuyahoga County locals with any similar request. The filing deadline for both party primaries is February 5; local representatives will consider whether to make a recommendation in the Republican primary after that date.

SERS December 19, 2013 Board Meeting Report

The CAFR, which contains a detailed look at the System's financial status and investment activities, as well as actuarial and statistical information for the fiscal year ending June 30, 2013, is available on SERS' website. Also, for the second consecutive year, SERS will publish a Summary Annual Financial Report (SAFR), an 8-page document that summarizes the financial information contained in the CAFR. It is available on the website too.

Investments Update

As of October 31, the value of the fund was \$11.93 billion, up \$570 million from September. For FY2014, investments were up 7.67%, and for the calendar year, investments were up 13.00%.

Year-end Federal Update

Jim Miller, SERS' federal government liaison based in Washington, DC, briefed the Board on pension issues legislators tackled in 2013 and those that could arise in 2014.

Miller praised the Ohio delegation for their knowledge and support of Ohio's pension systems, and said that SERS and the other Ohio pension systems do a great job of providing legislators with data showing the economic impact of retirees in their districts.

One issue he believes will attract significant attention from legislators in 2014 is the implementation of new Governmental Accounting Standards Board (GASB) guidelines for reporting pension liabilities. The new GASB standards focus on accounting rather than funding and have the

potential to make public pensions appear as if they are underfunded when they are not. Miller said that Ohio's public pension systems are far ahead of other states in educating state and federal legislators about the GASB changes.
