## Budget Bill (HB 59) Passes Senate and Now Heads to Conference Committee.

The Senate Finance Committee amended House Bill 59, the budget bill for FY 14 and FY 15. The bill passed the Senate Finance Committee with a party line vote of 9-4 and on June 6, 2013 passed the Ohio Senate after lengthy debate by a vote of 23-10. The Senate-passed version of the bill makes positive changes to certain education-related issues.

## House Bill 167 ("Columbus Plan") Passed by Ohio House; Senate Hearings Underway

House Bill 167, was recently introduced after months of deliberation by the Columbus Education Commission on how to best address the issue of improving education in the Columbus City Schools. The Columbus Education Association was represented on the Commission as various reform measures were considered. The Columbus Education Association supports the package contained in House Bill 167. As this legislation is the result of a local reform process, the OEA has been closely monitoring the bill as an "interested party" as it receives hearings in the Ohio General Assembly.

## Hearing Held on So-Called "Right to Work" Legislation – House Bill 151 and House Joint Resolution 5

On June 4, 2013, the House Manufacturing and Workforce Development Committee held a hearing on House Bill 151 (R-Roegner) and House Joint Resolution 5 (R-Roegner/R-Maag), which are two of the three so-called "right-to-work" bills recently introduced in the House. House Bill 151 applies to private sector employees, and House Joint Resolution (HJR) 5 would put a so-called "right to work" law on the ballot to be amended into the Ohio Constitution. HJR 5 would apply to both private and public sector workers. The third right-to-work bill, House Bill 152 (R-Maag), would apply to public employees like OEA members, but has yet to be scheduled for a hearing in the House State and Local Government Committee.

The Ohio Education Association and the We Are Ohio coalition will continue to strongly oppose House Bill 151, House Bill 152 and HJR 5. These so-called "right to work" bills are the latest attack on Ohio's working families. Just like Senate Bill 5, these bills would hurt the middle class, provide less freedom in the workplace and make us all less safe.

# OEA-R and ORTA What's the Difference?

Many retired OEA teacher members are also members of the Ohio Retired Teachers Association (ORTA). Unlike OEA's structure, ORTA's emphasizes county chapters, which means that if you're interested in attending a

gathering of retired educators you might look into a retired chapter near you. Most chapters hold reasonably-priced luncheon workshops.

Chapters may have their own dues and keep their own mailing and membership lists, but most welcome nonmembers and guests at their luncheons.

If you're interested in finding a chapter meeting, the best way is to go to the statewide ORTA website, <a href="http://www.orta.org">http://www.orta.org</a>, and click on the link marked "ORTA Chapter Webpages." To see the information for your county chapter, click on the link.

Like nearly one-third of NEOEA's members, I live in Cuyahoga County; so I've made it a point to attend some recent meetings of ORTA's Greater Cleveland Chapter (online at <a href="http://gccorta.com">http://gccorta.com</a>). They meet at the Valley Inn, in the Cuyahoga Valley Career Center in Brecksville; they have 2013 meetings scheduled for September 11, October 9, and November 13. (They generally meet on the second Wednesday of the month, and their 2014 meeting dates aren't posted yet.)

No one should confuse ORTA with OEA-R! ORTA's Regular members include teachers and administrators retired under STRS with Associate membership is available for others. OEA R members must have been an OEA Member for one year and retired under any of the Ohio retirement systems. At ORTA meetings, you'll meet administrators and members of other professional organizations besides OEA. Their policy aims and their political endorsements aren't always the same as OEA's. Nonetheless, you may find their sessions to be interesting and informative. I've attended three GCC-ORTA meetings, and I enjoyed them all.

## Senior Voice Provides Speakers to Senior Groups
