#### OEA-Retired Advisory Council and NEA-Retired Delegate Elections

The OEA-Retired election for Spring 2018 is being conducted by Election America. Online voting opens on March 2, 2018, and closes on March 30, 2018, at 5:00 p.m. (eastern).

Election notices will be mailed on February 28 (and emailed, if on file) to OEA-Retired members with an individual Election Code and Voting PIN (you will need these to vote). If you have not received the notice by March 7, please contact Election-America at <u>Help+OEAR@election-america.com</u> or call (855) 306-0501.

The deadline to request a paper ballot is March 14, 2018. If you would like to request a paper ballot, please contact Election-America by calling (855) 306-0501 or email at <u>Help+OEAR@election-america.com</u>.

The Ohio NEA-R delegation consists of nine delegate seats, the Chair is a delegate by virtue of office. There are 33 candidates running for the remaining 8 seats. Eleven candidates are from NEOEA; two from Capital; five from Central; two from ECOEA; four from NCOEA; one from NWOEA; three from SWOEA; and five from WOEA.

The candidates for NEA-R Delegate from NEOEA are (in alpha order): Homer O. Adams; Barbara Catalano; William Dorsey; Martha Franks; Peg Ham; Lynnette Harris; Norman Hillstrom; Joyce Hives; Adele Matias; Donna Smoot Walters; and Beverly A. Woolridge. Names will be randomly drawn for order on the ballot.

Two candidates are running for OEA-R Vice-Chair: Donna Smoot Walters, Copley (NEOEA) and Mary Binegar, Springfield (Central).

February's SERS Board of Directors meeting was followed by their board retreat the next day. I was invited to attend and did so. It cleared up many questions I had about the investment process and reassured my faith in this Board of Directors. They are making the best decisions for us based on the rules the legislators have imposed on us. The actuaries have given them a rating above "Best Practice". #### **Retired Dues Increase Nears**

It has been at least 15 years since OEA has raised the OEA-R dues. At the most recent OEA Board of Directors meeting, a motion was made by OEA Secretary-Treasurer Tim Myers, during his budget report, to increase the OEA-R membership dues. The OEA-R annual dues would be set at \$25 (\$10 increase) and the OEA-R Life Dues would become \$150 (a \$50 increase). The new budget will be presented to the delegates at the Spring OEA RA. If accepted by the delegates, it would become effective by September 1, 2018.

It is also rumored that NEA may also increase the NEA-R Life dues by \$50 this September. That could cause an increase of \$100 for a combined OEA-R/NEA-R Life membership. Although it is not clear that NEA-R dues will increase, the OEA-R dues are very likely to increase.

To lock in the \$350 current rate for the combined OEA-R/NEA-R Life Membership and avoid the dues increase to \$450, we strongly encourage you to inform all active teachers to join as a Pre-Retired Life Member between now and September. Their membership will convert seamlessly when they retire. Of course, if you are a currently retired teacher, but have not yet joined OEA-R and NEA-R, please take advantage of this opportunity now.
