OEA Legislative Scorecard – A Legislative Scorecard for each Member of the Ohio General Assembly

OEA Government Relations has developed and will maintain a legislative scorecard for each member of the Ohio General Assembly. It tracks floor votes on bills that OEA has taken a position (support/ oppose) as well as notified OEA voting members of the same. Additionally, co-sponsors of bills that OEA has intense interest (either in favor or against) are also tracked. Scorecard at https://www.ohea.org/get-involved/legislative-scorecard/.

Here is a list of legislative issues that OEA is tracking:

- HB 21 would improve charter student residency verification. OEA supports this bill. It passed the House 94-0.
- HB 87 requires misspent public funds recovered from charter schools to be returned to school districts. OEA supports this bill. It passed the House 94-2.
- HB 53 is Right to Work is wrong legislation for the public sector. OEA opposes this bill.
- HB 113 is Right to Work is wrong legislation for the private sector. OEA opposes this bill.
- HB 200 would greatly expand private school vouchers in the state. OEA opposes this bill.
- HB 298 would reduce sick leave for public employees and exclude sick leave from collective bargaining. OEA opposes this bill.
- HB 512 would consolidate the Ohio Department of Education, the Ohio Department of Higher Education, and the Governor's Office of Workforce Transformation into a single cabinet-level agency and strip the State Board of Education of most of its functions. OEA opposes this bill.
- House Bill 572 requires the Ohio Public Employees Retirement System (OPERS) to grant a full year of service credit to certain employees of County Boards of Developmental Disabilities. OEA supports this bill.
- HJR 7 is a proposed constitutional amendment to institute Right to Work is wrong for the public sector. OEA is opposed.
- HJR 8 is a proposed constitutional amendment to institute Right to Work is wrong for the private sector. OEA is opposed.
- HJR 9 is a proposed constitutional amendment eliminating prevailing wage. OEA is opposed.
- HJR 10 is a proposed constitutional amendment prohibiting project labor agreements. OEA is opposed.
- HJR 11 is a proposed constitutional amendment requiring annual recertification for labor unions. OEA is opposed.
- HJR 12 is a proposed constitutional amendment prohibiting payroll deduction for union dues. OEA is opposed.

Here is an excerpt from the history as narrated by Bill Lavezzi on our website:

For a year or two a number of superintendents and teachers of the schools, in the cities and towns of which Cleveland is the commercial center, had been accustomed to meet frequently and exchange views on questions pertaining to their special work. These informal meetings were felt to be profitable to those engaging in them. The opinion was generally entertained that there was professional interest among the teachers to warrant an organization which should hold meetings at stated times, thus securing agreement as to time of meeting and questions to be considered. Accordingly, on Saturday, November 13, 1869, a few gentlemen met in one of the rooms of the Weddell House, and there organized the North-Eastern Ohio Teachers' Association.

OEA Retired Dues Increase Passed

It has been at least 15 years since OEA has raised the OEA-R dues. At the most recent OEA Board of Directors meeting, a motion was made by OEA Secretary-Treasurer Tim Myers, during his budget report, to increase the OEA-R membership dues. The OEA-R annual dues would be set at \$25 (\$10 increase) and the OEA-R Life Dues would become \$150 (a \$50 increase). Combined OEA-R and NEA-R dues will be \$400. The new OEA budget was approved at the Spring OEA RA. The new dues rate will become effective by September 1, 2018.

The rumored NEA increase in NEA-R Life dues by \$50 for this September appears to be on hold until next year. It would cause an additional \$50 increase to \$450 for a combined OEA-R/NEA-R Life membership if and when it occurs.

To lock in the \$350 current rate for the combined OEA-R/NEA-R Life Membership and avoid the dues increase to \$400/\$450, we strongly encourage you to inform all active educators to join as a Pre-Retired Life Member between now and September. Their membership will convert seamlessly when they retire. Of course, if you are a currently retired educator, but have not yet joined OEA-R and NEA-R, please take advantage of this opportunity now.
